## URGENT ALERT

Please call your legislators today in Frankfort. In Governor Bevin's budget request, he is asking every cabinet to cut their cost to 4.5% starting now and then an additional 4.5% for next year's budget. Our Family Resource/Youth Service Centers will be affected by these cuts. They serve in the Cabinet of Health and Family Services, not the Department of Education.

Our legislators need to hear from us how valuable and important it is to have our Family Resource Youth Service Center Coordinators. They are very important to our parents and their children. They help stop the social barriers that students have in trying to learn. They facilitate getting the students clothing, eye glasses, transportation, and many other barriers that would keep our students from coming to school or learning. They are the main staple in many of our children's lives.

Call your legislator today. Urge her/him to not cut our Family Resource Youth Service Centers.
