The grant does NOT cover any transportation, additional meals, or any additional expenses.

To Be Considered a Unit in Good Standing, the PTA/PTSA MUST:

- ◆ Send at least one national and KY PTA state dues payment to the KY PTA office no later than October 15th
- ◆ Send district dues to district treasurer or KY PTA office as required
- ◆ Send the PTA Financial Review Form to the KY PTA office and school principal by July 15th
- ◆ File 990 IRS Tax Form by Nov. 15 and mail a copy to the KY PTA office
- ◆ Send bylaws to the KY PTA office for approval every 5 years
